

PERSONAL DATA PROCESSING NOTIFICATION

As the provisions of **Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation)** (OJ L No 119), hereinafter the “**GDPR**”, entered into force on 25 May 2018, we would like to notify you of the following:

1. The Joint Controller of your personal data acquired by the Institute of European Network Remembrance and Solidarity in the context of your:
(i) PARTICIPATION IN TEACHERS WORKSHOPS: submission/recruitment process, registration and/or (should your submission be accepted) participation in the Workshops and/or the contract (by which we mean the RULES you’ve accepted during registration process and/or the separate agreement you have entered with the Institute), including:
 - 1) name and surname,
 - 2) e-mail address, phone number
 - 3) country of residence
 - 4) affiliation
 - 5) education, professional experience,
 - 6) your image (including the voice),
 - 7) and – as a case may be – other personal data, including special categories of personal data referred to in Article 9 of the GDPR (such as data revealing ethnic origin, political opinions, religious or philosophical beliefs or data concerning health) – if you decide yourself to reveal such data, which in such a case will be considered as (i) your explicit consent to process such data or (ii) as data manifestly made public by you – allowing the Joint Controller to process the data obtained during recruitment process and/or recorded in the context of your active participation in the workshops, and/or the contract,

3. Your Personal Data shall be processed by the Controller in compliance with the GDPR, for the purpose of requirement process and/or enabling your active participation in the Workshops and/or performing the provisions of the contract to be entered into between you and the Controller (among others by accepting the Rules Governing the Participation in Events), for the purpose of the organisation and delivery of the workshops for teachers during Sound in the Silence project for the purpose of carrying out promotional activities related to the Project, for the purpose of seeking claims or defending the Controller’s legal interests.
4. Your Personal Data shall be processed on the basis of the following legal bases:
 - 1) pursuant to Article 6(1)(b) of the GDPR - processing is necessary for the performance of a contract to which the data subject is party, which in this specific case shall be the ‘Rules Governing the Participation in Events of the Institute of the European Network Remembrance and Solidarity’;
 - 2) pursuant to Article 6(1) (f) of the GDPR - processing is necessary for purposes arising from legitimate interests pursued by the Controller or by a third party – by which is understood the promotion of the Events in which you will take part;
 - 3) pursuant to Article 9(2)(a) of the GDPR – the data subject has given explicit consent to the processing of those personal data for one or more specified purposes.
5. Your Personal Data shall be received by the following categories of entities:
 - 1) providers of technical services (including, for instance, telecommunications, hosting, owners of servers and spaces where data are stored, *inter alia* Google LLC,

- Microsoft, Zoom Video Communication Inc.), entities offering services related to conducting online activities.
- 2) entities providing the Controller with services in the scope of maintaining its profiles in social networking services, such as Facebook and Instagram, or in the scope of conducting promotional or marketing actions upon the Controller's request,
 - 3) entities offering online social media services (np. Facebook, X, YouTube),
 - 4) participants of the said Workshops,
 - 5) entities with which the Controller concludes any contracts concerning works containing your image or statements recorded in the context of your participation in the said Workshops and/or performing the provisions of the contract to be entered into between you and the Controller,
 - 6) other entities cooperating with the Controller in the context of the said Workshops (Institute of the European Network Remembrance and Solidarity, Warsaw) and Partners of the Project: Foundation European Network Remembrance and Solidarity;
 - 7) entities cooperating with the Controller,
 - 8) entities supervising the Controller's activities,
 - 9) employees and persons cooperating with the Controller.
6. The Controller, using the services offered by Microsoft, intends to transfer personal data to Microsoft Ireland Operations Limited One Microsoft Place South County Business Park Leopardstown Dublin 18, Ireland (hereinafter "Microsoft"), which may process (including transfer, store) data also outside the European Area Economic (EEA), including in the United States of America and in other countries where Microsoft or its partners have the appropriate infrastructure, based on standard data protection clauses referred to in Article 46 of the GDPR. Using services offered by Google, including the YouTube service (in compliance with the definition below), the controller intends to transmit your Personal Data to the company Google LLC of Delaware seated at Amphitheatre Parkway nr 1600, Mountain View, California 94043, USA or Google Ireland Limited ('**Google**'), which may process them (including transmission and storage) also outside of the European Economic Area (EEA), including the United States of America and other countries where Google or its partners has/have relevant infrastructure. To ensure safety, contracts with Google feature also standard contractual clauses approved by the European Commission. Google gives its assurances that when processing your Personal Data it applies appropriate safeguards at all times. Using services offered by Facebook (in compliance with the definition below), the controller intends to transmit your Personal Data to the company Meta Ireland Ltd., 4 Grand Canal Square, Grand Canal Harbour, Dublin 2 Ireland ('**Meta**'), which may process (including transmission and storage) them also outside of the European Economic Area (EEA), including the United States of America and other countries where Facebook or its partners has/have relevant infrastructure. Meta uses standard contractual clauses approved by the European Commission and its decisions acknowledging an adequate level of data protection with regard to specific countries, in relevant cases, as regards data transmission from the EEA to the United States and other countries. Using services offered by X (formerly Twitter – in compliance with the definition below), the controller intends to transmit your Personal Data to the company X Corporation, One Cumberland Place, Fenian Street, Dublin 2, D02 AX07 Ireland ('X'), which may process (including transmission and storage) them also outside of the European Economic Area (EEA), including the United States of America and other countries where X or its partners has/have relevant infrastructure, based on standard data protection clauses referred to in Article 46 of the GDPR. X gives its assurances that when processing your Personal Data it applies appropriate safeguards at all times. More details available at: <https://x.com/en/privacy>.

The controller may deliver the Events using the ZOOM platform provided by the American company Zoom Video Communications Inc. As a consequence, your Personal Data are going to be transferred outside of the European Economic Area in the scope of the service rendered by the provider ZOOM, based on standard data protection clauses referred to in Article 46 of the GDPR. 7. Your Personal Data shall be processed as of their submission until the day when the Contract has ceased to be in force, with the proviso that in case of data the Controller is obliged to process under commonly applicable legislation such data shall be processed in a period required by the relevant legislation.
8. You shall have the right to request from the Controller:
 - a. access to your Personal Data,
 - b. that your incorrect Personal Data be rectified without delay as well as to request (considering the purpose for which the data are processed) that incomplete Personal Data be completed,
 - c. that your Personal Data be erased without delay and the Controller shall be obliged to erase such Personal Data without undue delay (subject to the exceptions provided for in Article 17(3) of the GDPR),
 - d. that the processing of your Personal Data be restricted,
 - e. that the Personal Data you have submitted be transmitted.

9. You shall have the right to object to the processing of your Personal Data pursuant to Article 21 of the GDPR. You may send the objection referred to in this paragraph to the following email address: iod.enrs@enrs.eu.
10. You shall have the right to revoke your data processing consent at any time with no bearing on the legality of the processing performed under the consent prior to its revocation – this pertains to cases when your data are processed on the basis of your data processing consent.
11. Pursuant to Article 77 of the GDPR, you shall have the right to lodge a complaint with the President of the Office for Personal Data Protection or another body competent for personal data protection to replace the PUODO, as well as another supervising authority, should you find that the processing of your Personal Data infringes on the provisions of the GDPR.
12. The submission of your Personal Data shall be voluntary, subject to its being a requirement for enabling your active participation in the said Conference, and/or performing the provisions of the contract, and enabling you access to the conference.
13. You shall not be subject to any decisions based solely on automated processing which produce legal effects concerning you or similarly significantly affect you.
