

**CONSENT TO THE PROCESSING OF PERSONAL DATA
AND LIKENESS RELEASE**

1. **Consent to the processing of personal data, I the undersigned**
....., **hereby consent to the processing of my personal data** by the European Network Remembrance and Solidarity Institute, ul. Zielna 37, 00-108 Warsaw, in order to organise, implement, and promote the competition **“Grand Stories: Journalism Awards”**.
The legal basis for data processing is Article 6(1)(a) of the GDPR of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation) (Journal of Laws of the European Union of 2016 No. 119), p. 1, as amended).
2. **Likeness Release**
I the undersigned, hereby consent to the free use of my image by the **European Network Remembrance and Solidarity Institute** in connection with participation in the **“Grand Stories: Journalism Awards” competition**.
3. This consent includes the publication of my image on the competition organiser’s website, in social media, in materials promoting the competition, as well as in other forms of promotion, without time and territorial limitations. This consent may be withdrawn at any time, but the withdrawal of consent does not affect the lawfulness of the processing of the image prior to its withdrawal.
4. **GDPR Information Clause**
Pursuant to Article 13(1) and (2) of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data (GDPR), I hereby inform you that:
5. **Personal Data Administrator:**

6. **Data Protection Inspector:**

7. **Purpose of data processing:**
My personal data will be processed for the purpose of organising, implementing and promoting the competition **“Grand Stories: Journalism Awards” competition**.
8. **Legal basis for processing**
The basis for the processing of personal data is Article 6(1)(a) of the GDPR (consent of the data subject).
9. **Recipients of the personal data:**
The recipients of the personal data may be persons or entities to whom the organiser of

- the competition provides data for the purpose of promoting the competition, including publication on the website, in social media, as well as other communication channels.
10. **Data retention period**
My personal data will be stored for the time necessary to achieve the purpose of processing, i.e. for the time of the organisation, course, and announcement of the results of the competition, as well as for promotional purposes. Personal data will also be deleted in the event of withdrawal of consent or upon the request of the data subject.
11. **Automated decision-making**
My personal data will be processed by automated means, but will not be subject to automated decision-making, including profiling.
12. **Data transfers outside of the EEA**
My personal data will not be transferred outside of the European Economic Area (EEA).
13. **Rights of the data subject**
In connection with the processing of personal data, I have the following rights:
- a) right of access to my personal data,
 - b) right to rectify incorrect data,
 - c) right to request deletion of data, if the conditions of Article 17 of the GDPR are met,
 - d) right to request the restriction of data processing,
 - e) withdrawal of consent at any time, which will not affect the lawfulness of processing prior to its withdrawal.
14. **Complaint to the President of the Office for Personal Data Protection**
I hereby reserve the right to lodge a complaint about the unlawful processing of personal data with the President of the Office for Personal Data Protection, ul. Stawki 2, 00-193 Warsaw.
15. **Voluntary provision of data**
Providing my personal data is voluntary, however, failure to provide this data may result in the inability to apply for participation in the competition.
